TA in Action

Cross-State Learning Collaboratives

Over the past five months, NCSI held nine face-to-face cross state learning collaborative (CSLC) meetings to launch CSLCs representing literacy and language, mathematics, graduation and post school outcomes, systems alignment, results based accountability, social emotional development and family outcomes. Approximately 761 participants, representing 41 states, DC, and eight territories participated with some states sending teams for both Part B and Part C and some participating in more than one CSLC.

In January, NCSI's Systems Alignment Learning Collaborative held the final face-to-face kick-off meeting in Phoenix, Arizona. The in-person face-to-face meeting brought together more than 70 collaborative members from nine states, who had already participated virtually for a number of months.

Through cross-state sharing and individual state team work, participants identified technical and adaptive challenges and opportunities in aligning systems within the state education agency (SEA) and among the local education agencies (LEAs) they support. As a guide for the work, a tool, "Quilting Silos," was used with the participants to make concrete connections to their own work through the unpacking of a hypothetical, but all too real, SEA-based

scenario. Also present at the event were U.S. Department of Education staff, including Michael Yudin, Assistant Secretary for Special Education and Rehabilitative Service, and Dr. Monique Chism, Deputy Assistant Secretary for Policy and Programs, Office of Secondary and Elementary Education. States had an opportunity to hear the "View from Washington" regarding the federal perspective on systems alignment and to dive deeper through a question-andanswer session addressing the application of the federal perspective, including the passage of the Every Student Succeeds Act (ESSA). A state attendee shared, "The thoughtful planning of NCSI was phenomenal! Very intentional activities and you could tell a lot of thought and time went into it."

Following the face-to-face meetings, CSLCs have shifted to ongoing virtual collaboration. CSLCs are hosting webinars, discussion forums, and sharing resources. Virtual collaboration is supported through individualized <u>CSLC Ning</u> <u>sites</u> that were developed to encourage member interaction and sharing of resources. The Ning sites are password protected and open only to members of the Learning Collaborative community. NCSI Hosts Thought Leader Forum on Levels of Evidence

On February 17–18, 2016, the Knowledge Utilization team hosted a thought leader forum titled "Levels of Evidence for Evidence-Based Practices." This forum included parents, technical assistance providers, researchers, and federal, state, and local representatives with expertise in Part B and C. Meeting participants worked to identify common challenges, needs, and points of confusion about evidencebased practices; discussed and developed criteria for talking about evidence quality across levels of a system; and identified resources to be developed and disseminated by NCSI.

How do we evaluate and measure our State Systemic Improvement Plan (SSIP) implementation?

The focus of the Data Use service team is to promote the use of high-quality data as the basis for the development, implementation, and evaluation of the SSIP. Team members are content specialists in planning evaluations, collecting data, improving data systems, analyzing root causes, selecting appropriate data sets to inform decision making, and applying data for decision making. The NCSI Data Use team works closely with the IDEA Data Center (IDC), Early Childhood Technical Assistance Center (ECTA), The Center for IDEA Early Childhood Data Systems (DaSy), and other TA centers to develop tools and resources to support evaluation and data collection efforts.

Considerations for Making Changes to SiMR Baseline and Targets addresses factors that could lead Part C or Part B state agencies to propose a change in their SiMR baselines or targets.

IRIS, CEEDAR, and NCII Collaborate on New Modules In collaboration with NCII and CEEDAR, the IRIS Center has released two new modules focused on intensive intervention. Part 1: Using Data-Based Individualization to Intensify Instruction presents an overview of data-based individualization as well as information about adaptations for intensifying and individualizing instruction. Specifically, the resource discusses collecting and analyzing data from progress monitoring and diagnostic assessments. and states are designed to measure student achievement of rigorous college- and career-ready standards. Recent surveys of teachers in several states indicate that students with disabilities like many features of the new assessments, but that there also are challenges. Many of these challenges are related to instructional issues that need to be addressed to improve student outcomes. In the recently released brief, Lessons Learned About Instruction from Inclusion of Students with Disabilities in College and Career Ready Assessments, NCSI and NCEO provide information and suggestions for SEAs and other TA providers who work with LEAs.
