NCSI Presents Multiple Sessions at CEC



Presenters were happy to have many local practitioners as participants in the CEC sessions, but were surprised to observe that few were familiar with Results Driven Accountability or knew their state identified measurable result (SiMR). OSEP Announcements

Differentiated Monitoring and Support Rollout

OSEP recently released the Results Driven Accountability Differentiated Monitoring and Support Notice (DMS Notice) for Federal fiscal year (FFY) 2015. For this fiscal year, OSEP will focus on Part B with both Part B and Part C launching in FFY 2016. [Learn more.](#)

- Alignment of the Every Student Succeeds Act (ESSA). This subteam is planning for a Thought Leader Forum to engage in shared learning and facilitated conversation aimed at identifying tangible issues and compiling recommendations to support states on this topic.
- Infrastructure for design and implementation of effective professional development efforts for staff supporting Part B and C programs at the state and local levels.
- High-leverage teaching and learning conditions that bridge special education and general education for core instructional skills.

A number of products and resources addressing these topics will be available soon.

The Center for IDEA Fiscal Reporting (CIFR) has developed the [Maintenance of State Financial Support Toolkit](#), which contains four tools to help SEAs with MFS: the Quick Reference Guide, the Funding Flow Ideograph Tool, the Timeline Development Tool, and the Data Collection and Reporting Tool. Together, these tools may be used by states to help key stakeholders to better understand the MFS requirements, standardize state MFS data collection and reporting processes, and support the submission of high-quality MFS data. Finding Evidence-Based Practices: NCII Tools Charts and NTACTION Effective Practices and Predictors Matrix

Identifying evidence-based programs and assessments can be challenging. The [National Center on Intensive Intervention \(NCII\)](#) and the [National Technical Assistance Center on Transition \(NTACT\)](#) provide resources to support states, districts, and schools in identifying effective practices that meet their needs.

NCII has developed and published a series of interactive tools charts to assist educators and families in becoming informed consumers who can select academic and behavioral progress monitoring tools and interventions that best meet their needs. The four tools charts, [Academic Progress Monitoring](#), [Academic Intervention](#), [Behavioral Progress Monitoring](#) and [Behavioral Intervention](#) have been updated to include new tools and improved functionality and design. NTACT has developed an [Effective Practices and Predictors Matrix](#) to review practices and predictors that promote positive postschool outcomes for students with disabilities. Practices and predictors are evaluated on the amount, type, and quality of the research conducted and are labeled as either (a) [evidence based](#), (b) [research based](#), or (c) [promising](#). These designations indicate the confidence one can have in the likely effectiveness of the intervention when implemented as defined and recommended.
