TA in Action

Developing Tools to Ensure Coherence in the Face of Change

State educational agencies and lead agencies, particularly in Part C, face real challenges from staff turnover. Members of the social emotional outcomes cross-state learning collaborative—representing Alaska, Maryland, North Carolina, and Texas—developed two resources that states can use to create coherence in the face of such change. <u>My Position Roadmap</u> is a fillable PDF file in which staff document the technical and adaptive elements of their job. This resource documents the "five W's" of a position, including what the role looks like, who they interact with, where key resources are located, and more. The second resource, <u>Exit Interview Questions</u>, includes a list of key questions that can be used to explore the reasons why someone is leaving a job and how that information can be used to shape positions to better retain staff in the future. These resources can be used as is or adapted to meet your context.

Vermont and Oklahoma Working Together on Results-Based

Accountability

At the NCSI cross-state learning collaborative convening in October 2018, Oklahoma staff shared their revised General Supervision manual with the Results-Based Accountability Collaborative. At this time, Vermont began to reflect on its general supervision system and ways to amplify the state's focus on improving results while continuing to ensure compliance with the Individuals with Disabilities Education Act (IDEA). Vermont planned a 2-day, onsite meeting in February 2019 to initiate a comprehensive review of its general supervision system and invited NCSI staff (including Susan Hayes, Kathleen Pfannenstiel, and Kate Nagle) and Ginger Elliott-Teague, Oklahoma's Part B data manager and coordinator of the State Systemic Improvement Plan (SSIP), to support the process. The team used NCSI's new resource,

Leveraging General Supervision Systems to Improve Student Outcomes: A Process Guide for IDEA Part <u>B</u>, to structure and guide the conversation. During this face-to-face event, the Vermont special education team—along with representatives from the multi-tiered system of supports team, the fiscal team, and the Every Student Succeeds Act (ESSA) team—reviewed current processes and identified strategies for increasing the state's focus on improving results and ways to integrate SSIP, ESSA, and fiscal elements into the work of the special education team. Vermont is excited to dive into the work ahead and is hopeful that a revised General Supervision manual will be ready to be piloted soon!

Leading by Convening Self-Paced Modules and User Guide

NCSI is excited to release the full set of <u>five self-paced learning modules</u> that provide a comprehensive introduction to Leading by Convening:

- Module 1: Authentic Engagement
- Module 2: Coalescing Around the Issue
- <u>Module 3: Ensuring Relevant Participation</u>
- Module 4: Doing the Work Together
- Module 5: Reviewing and Reflecting on Engagement Over Time



These five modules range from 30 to 60 minutes, depending on the time devoted to learning activities. A companion <u>user guide</u> describes how the modules can be used as an individual self-study or facilitated through professional learning networks or communities or traditional workshops. The learning modules and the companion user guide are available on the <u>NCSI website</u>.

Coaching Module Part 2: Measuring the Fidelity of Coaching

Measuring the Fidelity of Coaching is the second in a series of self-paced, professional development learning modules that NCSI has developed on coaching for teachers who work in the kindergarten–12th-grade setting. Module 1 focused on effective practices for coaches. Module 2 addresses how to measure the fidelity of coaching practices to increase their impact on teaching and learning. The module also features other resources:

- Effective Coaching of Teachers: Fidelity Tool Worksheet
- Effective Coaching of Teachers: Completed Sample of the Fidelity Tool Worksheet
- Effective Coaching of Teachers: Fidelity Tool Rubric

Although this module reviews the concept of fidelity and key components of fidelity, we strongly recommend watching Module 1 to fully enhance the coaching of teachers. <u>View both modules in the NCSI resource library</u>.

National Center on Educational Outcomes (NCEO) Recent Resources

In February 2019, NCEO released <u>Data Analytics: Percent of Students with Disabilities by Disability</u> <u>Categories for 2005-06 to 2016-17</u>. This interactive online resource includes information about the percentage of students with disabilities, as indicated in an Individualized Education Program (IEPs), for each of the 13 disabilities categories for all 50 states. The resource presents an overview of the percentage of students with disabilities per state, trends over time, the percentage of students for each disability category, and state profiles.

In March 2019, NCEO also released <u>Diploma Options</u>, <u>Graduation Requirements</u>, and <u>Exit Exams for</u> <u>Youth with Disabilities: 2017 National Study</u>. This report updates the status of graduation policies across the nation, including a look at graduation requirements and exit exams, diploma options, and more. The IRIS Center Releases New Module on IEPs

IEPs: Developing High-Quality Individualized Education Programs is designed for use by faculty in preservice courses, for those conducting professional development trainings, and for both novice and experienced educators. This module discusses the requirements for IEPs, as outlined in IDEA, with implications of the Supreme Court's ruling in *Endrew F. v. Douglas County School District*. The module can be used by those with little prior knowledge as well as those who are interested in exploring specific areas in more depth. <u>View the module here</u>.
